COVID-19

SKI LODGE & DEPARTMENT OF HEALTH REQUIREMENTS

- Individuals risk a \$2,726 fine for breaching requirements to isolate or quarantine under a direction from the Department of Health.
- 6000+ covid cases and 30 deaths are reported daily in Victoria
- Take a RAT test before arriving at the lodge even if you have no symptoms.
- Bring 1 RAT test per person per day for mandatory testing should there be a positive case reported at the lodge and you are a close (household) contact.
- Take a RAT test even if you have mild symptoms / advise the manager if you get a positive.
- Cancellations due to Covid will receive a full refund. Positive cases must return home for quarantine and will be refunded for the balance of their booking.
- Please read the Covid Safe Plan posted on the Arrabri website and hard copy in the lounge and dining room

COVID-19

THE BASICS

- Do not enter the lodge if you are subject to quarantine requirements having tested positive in the last 7 days
- Arrabri asks that you have a RAT test before entry
- Good hygiene practices are critical to minimise Covid transmission.
 - Clean and disinfect surfaces in common areas before and after use in particularly the kitchen and dining room.
 - Assist by completing assigned cleaning tasks according to the cleaning schedule.
 - On the day of departure thoroughly clean your bedroom and complete the cleaning register.
- Restrict access to the lodge – no visitors / members and guests only.

Vaccination and Checking-in

You are not required to show your vaccination status before entering any venue such as food and drink venues, nightlife venues, entertainment venues, events, tourism venues, casinos/gaming venues or adult entertainment venues.

You are also not required to check-in to any venue using the Service Victoria app.

Many workers will need to have at least two vaccination doses if working outside your home.

Workers in high-risk settings such as healthcare and aged care will need to have three vaccination doses if working outside your home.



Visiting Hospitals and Aged Care

Residents at care facilities can have up to five visitors per day if they are able to show a negative rapid antigen test result.

If the facility does not have rapid antigen tests, the resident may have up to two visitors per day.

We strongly recommend that all residents and visitors have three vaccination doses.

Visitors to hospitals must wear a mask and follow the policies and rules set by each hospital.



Masks

Masks are required in limited high-risk settings including:

- While visiting a hospital, care facility or an indoor publicly accessible area in a healthcare setting, including allied health settings.
- At publicly accessible areas of an airport and on public transport, in taxis/rideshare services, in tourism vehicles and on commercial flights.
- Working in high-risk settings including healthcare, aged care and justice settings.
- After being tested for COVID-19 and awaiting results, other than as part of surveillance testing.
- If the person has COVID-19 or is a household contact, and is leaving the premises in line with quarantine, isolation or testing requirements.



Testing, isolation and quarantine

If you test positive for COVID-19, you are required to self-quarantine for seven days from the day you took your test.

If you have spent more than four hours with someone who has had COVID-19 inside a house, accommodation or care facility, you are a household contact.

A household contact must isolate for seven days from the date you were exposed, unless you:

- test negative using a rapid antigen test on 5 days of the 7-day period (with tests spaced at least 24 hours apart)
- wear a mask indoors when outside your home
- avoid hospitals and care facilities

You are exempt from testing or quarantine for 12 weeks after you've had COVID-19.



COVIDSafe Workplaces

All workplaces must have a COVIDSafe Plan.

Third dose vaccinations will be mandatory for the following high-risk workforces:

- Healthcare workers
- Aged care workers
- Disability workers
- Emergency services workers
- Correctional facilities workers
- Abattoirs, meat, poultry and food processing workers
- Food distribution workers
- Quarantine accommodation workers
- School and early childhood workers and volunteers

ENTRY

To enable the orderly arrival and departure of guests and cleaning and inspection of rooms Check-out prior to 2pm and Check-in after 4pm.

Your allocated bedroom is shown on the screen in the shedding room.

Please complete the [*Welcome to Arrabri Introduction*](#) before entry. A hard copy is on the bookcase near the first aid kit outside Bedroom 7 (Mangers Room) and in the lounge room.

Please contact the Managers on arrival to confirm your bedroom is read for entry

LODGE TOUR

SKI LODGE – is centrally heated. Thermostats in each room. Free WiFi

ENTRY LEVEL – GROUND FLOOR

- Shedding room – ski storage racks (Bedroom numbered)
- Drying Room – outer ski clothing, boots and gloves only (Bedroom numbered)
- Games Room – Pool table, Dart Board (own darts only), computer desk / work station, First Aid Kit and AED (Defib unit)
- Entertainment Lounge / Kids Zone – Television (Netflix) and Xbox
- Manager Room and Office (no entry)
- Laundry – washing machine and clothes dryer
- Ski Work Shop
- Wood Store
- Members Storage Lockers and Ski Storage

LODGE TOUR

FIRST LEVEL

- BEDROOMS 1 to 4 – 4 queen size beds and ensuite shower and toilet
- LOUNGE – Coonara wood heater / large comfortable lounges / Audio System with radio, CD and blue tooth connection / sweeping views to the Dargo High Plains
- DINING ROOM – 2 large and one smaller dining table – no computers at meal times. Hot water unit for coffee, tea and milo. Limit use of the door to the external balcony and consider the comfort of others by not leaving the door open. No food or drink storage on the balcony.
- KITCHEN – Stainless steel food preparation bench 3 microwave ovens, 2 gas ovens and cook tops, hotplate barbeque, commercial 3 minute cycle dishwasher, milk fridge, pantry and individual room numbered non-perishable food storage boxes.

LODGE TOUR

FIRST LEVEL

Off the kitchen

- COOL ROOM – 4°C (refrigerator temperature) with individual room numbered storage boxes for perishable food and drinks
- REFRIGERATOR and FREEZER – *mainly for Manager use.*
- HOUSE KEEPING items and BINS FOR RECYCLABLES

SECOND LEVEL

- BEDROOM 5 & 6 - 4 double beds, ensuite shower and toilet

PLEASE USE BEDROOM NUMBERED STORAGE

DRYING ROOM CLOTHING AND GLOVE STORAGE

SAFETY

- The Lodge is fitted with infrared and thermal detectors throughout which will activate the fire alarm system (tested monthly). 85dB alarm speakers in all bedrooms.
- Orderly evacuation – observe EXIT signs / Fire Orders posted throughout the lodge
 - Downstairs to ground level. Exit via the shedding room and main entry door,
 - First level exit via the dining room balcony door and external fire escape
 - Second level emergency exit door via Bedroom 6 and external fire escape
- **Assembly Point** – Zoo Cart Park opposite, across Davenport Drive
- Manager will conduct a head count to account for any missing persons
- Fire extinguishers throughout, hose reel and fire blankets in the kitchen

CODE OF CONDUCT

BEHAVIOUR. Members and guests are responsible for their own proper conduct. Rude, aggressive, bullying, unacceptable or offensive behaviour or language will not be tolerated.

CHILDREN. Arrabri Ski Club is a family-oriented ski club and children are always very welcome at all times. Parents or guardians of young children are responsible for their children's behaviour and must adequately supervise them at all times.

NOISE. Excessive noise or any other activity likely to disturb members or guests will not be tolerated. Consideration for others and the manager/s is expected. No noise is expected from midnight to 7am.

SMOKING. Smoking is prohibited within the Lodge and within 2.0 meters of external doorways.

DINING TABLES. All tables must be clear of laptops, books, puzzles etc. during peak meal times.

CODE OF CONDUCT

DAMAGE – Any damage must be reported to the Manager.

COMMITTEE DISCRETION – Members and Guests may be refused accommodation if their conduct is found to be unacceptable.
